## BBR New Member/Non-Qualifier Entries & Fees

- List *registered name* of horse and mark all races they are entering. Negative coggins (and health papers when applicable) will be required at check-in.
- Contestants who are Qualified for the BBR World Finals may NOT enter the NMNQ race. NMNQ, Gold Card and Youth (12&Under) Race will run Thurs, Fri & Sat. All are one race over three days. A horse/rider combination may only enter the Gold Card and Youth races once. A horse/rider combination may enter the NMNQ race twice and will be drawn on different days.
- Please indicate if a horse is also being run in the Invitational ShootOut or BBR Futurity so that it can be drawn accordingly.
- Number of stalls requested includes horse and tack stalls.
- Processing fee is one time per rider.
