A horse/rider combination may only enter the Gold Card and Youth races once. A horse/rider combination may enter the NMNQ race twice and will be drawn on different days.
- Please indicate if a horse is also being run in the Invitational ShootOut Races or BBR Futurity so that it can be drawn accordingly.
